We're also pleased to announce the publication of Mr. Mittman's new book, 5



A: Yes, you can be reimbursed for out of pocket expenses and mileage. Be sure to keep track of your mileage! If you have to pay out of pocket to travel to

and from a doctor due to a work related injury, you can receive a reimbursement whether you travel in your car, you pay a friend, you take a taxi or travel on the train or bus. Each year the New York State Workers' Compensation Board adjusts the amount of reimbursement per mile based on the state standard for government workers. **Visit our website, www.markhofflaw.com for specifics.**
